#### Points to be Noted:

i. The Service offers an health cover of Rs 5 lakh to 53 crore per annum to poor eligible citizens to avail cashless secondary and tertiary healthcare anywhere in the country in its empanelled healthcare providers- Both Public & Private(23,000).

ii. This will help the migrant workers. Till Now, 12.55 crore e-cards have been issued.

iii. To avail a PMJAY e-card, the beneficiaries need to obtain their individual and family verified UTIITSLs Centres or PSAs with the help of a document such as Aadhaar card.

iv. The registered beneficiary can avail the benefits under the AB-PMJAY scheme
